**Entry  
Rules**

Entry is limited to swimmers and divers competing for their high school.

1. An athlete may compete in four (4) events each day, no more than two (2) of which can be individual events.
2. Entry limits per team
  - a. 50 yard events – 18 entries per team
  - b. 100 yard free – 12 entries per team
  - c. All other events - six (6) individuals per event
3. It is important that coaches understand entering both days of this meet will count as two of 16 allowable regular school season meets. Schools may enter more than one relay per event but only one relay can score team points. Only one relay team per event per school can swim at night.

**NOTE: Disqualified relay swimmers in Prelims cannot compete on another relay in finals in the same event.**

The fee structure is **\$6.00 per athlete**. Maximum fees per team is \$360.00

**Coach/ Medical Forms** All competitors must have a coach present at all sessions to compete. Emergency Medical Information is to be in the possession of the coach (or school representative) at all times. A school representative may replace the coach provided he/she has a letter, on school letterhead from the School Administrator identifying the school representative. The letter must be presented to the Meet Referee/Official prior to the athletes warming up.

<b>Electronic Entries</b>	Entries will be submitted electronically. You may use HyTek team manager or Easy Team. The files can then be emailed to the respective meet entry chairperson.
<b>Web Site</b>	The meet information and the psych sheet will be posted on <a href="http://www.swimmeet.com">www.swimmeet.com</a> .
<b>Instructions for HyTek Team Manager</b>	Go to web site <a href="http://www.swimmeet.com">www.swimmeet.com</a> and download the event file for the Classic. Save the file on your hard drive. Import the event file. You now have a meet and you can do the entries right in HyTek team manager. The team manager will use the times that you have entered during the season. The entry file can then be exported and emailed to the entry chairperson for your site.
<b>Shaving</b>	Coaches, please warn your swimmers that no team personnel/competitor shall perform any on-site shaving before, during or after the meet. Team personnel/competitors shall be disqualified from further participation for on-site shaving. <b>Shaving on site is an ejection.</b>
<b>Miscellaneous Information</b>	<ul style="list-style-type: none"><li>• The top sixteen (16) swimmers in the prelims will advance to the finals. The eight (8) fastest will swim in the championship heat and the next eight (8) fastest will swim in the consolation heat.</li><li>• Prelims will be at seven (7) locations. The results from each event at each location will be transmitted to a central site where the qualifiers for finals will be determined and then transmitted back for posting. They will also be posted on the web <a href="http://www.swimmeet.com">www.swimmeet.com</a> as they become available. All qualifiers have thirty (30) minutes after the posting of each event's qualifier list to scratch finals without penalty.</li><li>• Penalty for a no show in finals without scratching – the swimmer/diver is disqualified from further competition that day.</li><li>• The 500 Free and the 400 IM will be timed finals with the fastest sixteen (16) at the finals</li><li>• The 1650 is a timed final event with the fastest eight (8) swimming at the finals. The swimmers in the mile may enter a 1650 yard time or a 500 yard time.</li><li>• Coaches, you must prove these times (400 IM or 200 IM for the 400 IM, 500 free, 1650 free or 500 free for the 1650 free) with meet results from high school, USA Swimming, or YMCA meets from the last calendar year. Failure to provide the proof of time shall result in the competitor being removed from that event. The 1650 will be swum fastest to slowest, alternating girls and boys.</li></ul>

1. There will be a warm-up procedure. Please follow it.
2. **All alternates for the finals must report to the referee when their event is called**  
A thirty (30) minute scratch rule will be in effect for **finals**. Swimmers failing to compete in an event without scratching will be disqualified from further competition. Penalty for a no show in finals without scratching – the swimmer/diver is disqualified from further competition that day.
3. Please adhere to the cut-off times for the 400 IM (or 200 IM for the 400 IM), 500 free and 1650 free (or 500 free for the 1650). **EVERYONE MUST PROVE TIMES IN THESE LONGER EVENTS.**
4. All relays will be prelims and finals.

## Diving PRELIMS General Information

The diving prelims will be held on Saturday January 19, 2008. WARM-UPS FOR DIVING PRELIMINARIES AT ALL SITES WILL START NO EARLIER THAN 12:00 PM (NOON).

Competition will begin 60 minutes after the warm-ups begin. Although there will be seven sites in swimming, diving will be at only four sites, Miami University, Mason Community Center, Trotwood-Madison High School, and Milford High School. Beaver creek divers will dive at Trotwood-Madison. Countryside divers will compete at Mason.

## Diving PRELIMS Entry Process

The diving form – **6 dives per diver** – must be sent via email Wednesday, January 16, 2008 4 PM to the persons identified below. **Both the diver and the coach must sign all diving sheets at the site 30 minutes before competition begins.**

All dive sheets will be printed out using E-Dive software. Each diver and coach will be expected to sign their dive sheets to confirm the information has been entered correctly. All signatures are required at least 30 minutes prior to the start of competition. A coach may make changes up to **30 minutes** before the meet begins. Each coach should use the diving site contact person and email the information to the contact persons below.

## Diving PRELIMS Diving Format

The diving prelims, consistent with the 2007-2008 National Federation rulebook will consist of six (6) dives. There will be no cuts. Each diver will perform all six dives. The dives shall consist of three (3) VOLUNTARY dives and three (3) OPTIONAL dives. The voluntary dives shall be done first followed by the optional dives.

Two (2) of the three (3) voluntary dives shall come from two groups – reverse and twisting. All voluntary dives shall be assigned their DD up to a value of 1.8. Any voluntary dive with a DD greater than 1.8 shall be assigned a DD of 1.8.

- a. The three (3) optional dives shall each come from a separate group – forward, back, reverse, inward, twisting. No more than one (1) optional dive from the same group is permitted.
- b. Any diver who cannot complete the required dives shall be ineligible for finals.

A copy of the dive sheets will be available when the scoring process is complete. Please do not take score sheets from the scorer’s table before the process is complete.

\*The top five (5) divers, both boys and girls, from the five diving sites (Miami A and B are two sites) will advance to finals on Sunday. A dive sheet for each finalist using an 11 dive format must be submitted to the diving Referee at the preliminary site immediately following preliminaries. If you think a diver will qualify for finals bring their 11-dive sheet with you to prelims on Saturday and submit.

The top five (5) scoring girl divers and boy divers from each site will qualify for Finals to be held At Sycamore High School Pool on Sunday, January 20, 2008. Warm-ups begin at 7:30 AM. Competition will begin at 9:00 AM and should conclude at approximately 3:00 PM.

Format**

The finals shall consist of five (5) voluntary dives and six (6) optionals dives for a total of 11 dives.

- a. The five (5) voluntary dives shall come from each of the five groups – forward, back, reverse, inward, twisting – with their assigned DD and have a sum of 9.0 or less.
- b. The six (6) optional dives shall include at least one (1) chosen from each of the five (5) groups. No more than one (1) optional dive from the same group is permitted through semifinals.
- c. All five (5) groups must be represented in the first eight rounds.
- d. The dives to be performed during each round of championship competition shall be as follows:
  - a. Preliminaries: Any two voluntary and three optional dives can be performed in any order with the preliminary round. The group will be cut to twenty (20) after prelims.
  - b. Semifinals: Two voluntary and one optional must be performed in any order with the semifinal round. The groups will be cut to sixteen (16) after Semifinals.
  - c. Finals: One voluntary and two optionals must be performed in any order in the Final round.



**\*\*All payments must have the name of the HIGH SCHOOL on the check or P.O. I do not know the districts of all the schools. \*\***

Due to the number of schools that are consistently late with their fees (70%) the following requirements will be imposed for your swimmers to be allowed to swim the first day of the meet. We realize that some school districts are slow to send out the money, so there are a number of ways to have the fees paid in time.

1. By January 19<sup>th</sup>, you must have sent a check or P.O. to my address-9805 Sparrow Place Mason, Ohio 45040
2. Present a copy of the invoice (signed by the A.D. or principal)
3. Present a copy of the P.O.
4. Write a check by the coach that I will hold (and return) after payment is received or it will be cashed on February 1st
